## THE US AND THE UK-HISTORICAL PERSPECTIVES

- Major differences in management of rape victims between US and UK.
- Some similarities- both follow an adversarial system of justice with evidence tested beyond reasonable doubt and a trial by jury.
- Can we learn from each other?

## DIFFERENCES BETWEEN US AND UK

 DEFINITION OF RAPE: In the US, each state has its own definition of rape whereas in UK, there is a single definition for England, Wales, Scotland and N.Ireland. In UK, Rape is defined as "The intentional penetration by a Penis of vagina, anus or mouth, B does not consent and A does not reasonably believe that B consents".

- 2. THE PROFESSIONALS:
- UK –Historically DOCTOR –led-developed from the male police surgeon role. Until very recently Doctors have been the only professionals carrying out S.O.E.
- US- responding to need a NURSE-led service was developed.

- 3.THE TRAINING:
- UK- This had been traditional theory based training with exams for doctors only- however a new exam – DFCASA. Standards in forensic training set by FFLM-Drs only can be full members.
- US- The training has been competency based with elearning modules and has been developed by nurses for nurses.

- LOCATION OF EXAMINATION:
- US- Examinations traditionally carried out in the ER in hospital setting. Some now carried out in community medical setting.
- UK.-Traditionally carried out in medical suite of Police station but now UK have developed a SARC for most counties.




- SARCs are defined by minimum standards set by DOH:
- MAIN FEATURES:
- Dedicated, forensically approved and cleanable premises.
- Access 24/7 to appropriately trained FP with choice of gender


# SARC FEATURES [CONT]

- SARC Team to include SARC Manager and a highly experienced Doctor as Clinical Director to ensure quality standards and training needs are met and to provide expert advice
- Immediate access to aftercare, including emergency Contraception, HIV PEP and Hep B vax.
- Support/ Advocacy to be provided by Crisis workers during the examination and by ISVA'S [Independent sexual violence advisors] post examination.









SUPPORT:

During the examination-UK-Crisis worker US-SANE Post examination-UK-ISVA [Independent sexual violence advisor.

US- Rape Crisis organisation

- EVIDENCE IN COURT:
- UK- Given by Doctors with Doctors only acting as Expert witnesses
- US- Nurses giving evidence in Court.

- CHILDREN-WHO EXAMINES?
- UK- Under 13's –Gold standard is a 2 Dr examination-Paediatrician + FME. 13-16 yrs 1 highly experienced Dr [FME] or FME +Paediatrician.
- US-Examination done by Nurses

## RESULTS OF SMALL UK STUDY OF NURSE EXAMINATIONS

- Doctors carry out 92.5% of examinations
- Nurses carry out 7.5% of examinations.
- RESULTS:
- Twice the number of complaints were received following Doctor examinations [in 2% of exams] as following Nurse examinations [in 1%of exams].
- CONCLUSION: Nurses give excellent service.

- THE BEST OF BOTH WORLDS:
- 1.Nurse model of care with Doctor as expert Clinical Director.
- 2. Specialist SARC as location
- 3.Aftercare on site-HIV PEP, Emerg Contracept
- 4. Crisis worker +ISVA equivalent for support/Advocacy.
